\_\_\_\_\_ 1. The Lessee agrees that he/she has personally inspected the Golf Cart at the time of pick up and accepts that the equipment is in good condition. The Lessee is responsible for any damage or loss of the Golf Cart.

\_\_\_\_\_ 2. The Lessee shall use the Golf Cart in a careful manner and shall comply with all rules and laws relating to its possession or use. The Lessee is responsible for the safety and security of the Golf Cart until it is returned to the possession of Normandy Farms Campground Reception Center. I am aware that there are areas of the park where golf carts are not permitted including, but not limited to, the pond area, disc golf, and dog park.

\_\_\_\_\_ 3. The Lessee acknowledges that he/she is personally responsible for any other drivers and insures that at no time will anyone without a valid driver's license be allowed to operate the Golf Cart. **MUST BE AT LEAST 18 YEARS OF AGE TO OPERATE. GOLF CART WILL BE IMMEDIATELY REVOKED WITHOUT REFUND IF LESSEE UNDER 18 OPERATES GOLF CART.** Please note that visitors are not permitted to operate Golf Carts.

\_\_\_\_\_ 4. All Golf Carts must have a pass displayed on the dashboard and must enter the assigned gate code upon entering the park.

\_\_\_\_\_ 5. Any damage, in transit (if being transported by the Lessee) or at place of use, is the responsibility of the Lessee, including cost of parts and labor. Normandy Farms Campground will not reimburse, nor be liable for any expenses not specifically authorized by it. Rental charges will not abate while equipment is under repair.

\_\_\_\_\_ 6. Do not decorate or use any tape or adhesives on Golf Cart or Lessee will be charged for damages.

Lessees warrant that he/she has sufficient funds to cover the replacement cost of equipment in the event that such equipment is lost, stolen, damaged, or destroyed. Lessee shall reimburse **Normandy Farms Campground**, upon demand, for the loss of, or any damage to the equipment while it was rented and for all costs and expenses, including reasonable attorney fees, incurred by **Normandy Farms Campground** in collecting any amounts owed.

Lessee shall indemnify and hold **Normandy Farms Campground** harmless from and against any and all liability, including bodily injury and property damage, arising out of the improper use or operation of the equipment by Lessee or anyone using or operating the same with Lessee's express or implied consent. Lessee shall not assign this Rental Contract or sublease the equipment. Lessee acknowledges that **Normandy Farms Campground has no insurance coverage on the Cart while it is in Lessee's possession, and the Lessee makes this material inducement for Normandy Farms Campground to enter this contract.**

\_\_\_\_\_ 7. **Security Deposit:** Lessee's signature below constitutes explicit approval to use the credit card on file to pay for the total amount of any loss or damage to the equipment during the rental period, plus rental charges. In addition to the damage fees, the Lessee will also pay for the time in which the Cart could have been rented had it not been damaged. **For this purpose, the Lessee's credit card information will be kept on file with this contract in the amount of \$500.00 per golf Cart as a security deposit. If damages exceed \$500, Lessee agrees to pay for all damages and rental fees.**

\_\_\_\_\_ 8. **Equipment Return:** Lessee agrees to return equipment in a clean condition, free of grime, grease, and debris. **Golf Carts must be returned fully charged.** I understand that the Cart is to be checked out at 3pm and returned by 12pm on my return date. If Cart is returned after 12pm, additional charges will be incurred.

\_\_\_\_\_ 9. Golf Carts must park in designated parking areas or on your site and the key should NEVER BE LEFT IN THE GOLF CART. If the Golf Cart is parked in a non-designated parking area, it may be moved by Management.

\_\_\_\_\_ 10. No driving Golf Carts while under the influence of drugs or alcohol. No open alcohol containers permitted on the Carts.

\_\_\_\_\_ 11. Maximum of 4 people on the Golf Cart. Golf Cart drivers cannot have anyone sitting on their lap and no one is permitted to stand while driving. Pets are not permitted on Golf Carts.

\_\_\_\_\_ 12. If camping on a tent site, Lessee is aware there may be no electricity and would need to charge the Golf Cart in alternate area.

## **Golf Cart Rules**

- a. Lessee must be 25 years old. Operators of golf Carts must be 18 years of age and have in their possession a valid driver's license. (Moped license, learner's permit, etc. are not accepted).
- b. Golf Carts cannot be operated during quiet hours 10pm-8am.
- c. Golf Carts must be operated properly. Horseplay, racing, or other misuse of Cart will not be tolerated. Carts are to be operated on blacktop or gravel campground roadways designated for both cars and Golf Carts (not on grass areas). Golf Carts are never to be used under the influence of drugs or alcohol.
- d. Golf Carts must remain on Normandy Farms property at all times and avoid areas where Golf Carts are not permitted.
- e. Golf Carts must be returned at the designated time. Late returned Carts will be charged \$20 for every hour late.
- f. Lost keys are \$25.
- g. Golf Carts can carry a maximum of 4 people.
- h. Please report any malfunctions to the Reception Center immediately.
- i. Golf Carts may not exceed 9 MPH.
- j. Anyone found abusing the rules and regulations of rental Golf Cart will forfeit all rental privileges. There will be NO REFUNDS made if the Cart has to be returned because of Lessee misuse.
- k. You, as the renter, are responsible for the Golf Cart and key at all times and therefore you are responsible for any and all damages that occur to the Cart during the time the campground is not in possession of the Cart. Be sure to place the parking brake on, the Cart in neutral and remove the key when parked.
- l. Golf Cart should be charged overnight to preserve battery.

**GOLF CARTS ARE ONLY TO BE OPERATED WITHIN THE CAMPGROUND BY A LICENSED DRIVER AND MAY NOT BE OPERATED BY ANYONE UNDER 18.**

**PICK UP TIME AFTER 3PM; RETURN CART BY 12PM (or late fee of \$20/hr. will incur)**

**IF A GOLF CART IS FOUND BEING OPERATED BY AN UNLICENSED DRIVER OR ANYONE UNDER 18, OR IF IT IS BEING OPERATED IN A RECKLESS MANNER, THE GOLF CART WILL BE IMMEDIATELY REVOKED AND THE RESERVATION FOR THE GOLF CART WILL BE CANCELLED WITH NO REFUNDS ON ANY UNUSED TIME.**
