If damages exceed \$500, Lessee agrees to pay for all damages and rental fees. 7. **Equipment Return**: Lessee agrees to return equipment in a clean condition, free grime, grease, and debris. Golf Carts must be returned fully charged. I understand that the Cart is to be checked out at 3pm and returned by 12pm on my return date. If Cart is returned after 12pm, additional charges will be incurred. 8. Golf Carts must park in designated parking areas or on your site and the key should NEVER BE LEFT IN THE GOLF CART. If the Golf Cart is parked in a non-designated parking area, it may be moved by Management. 9. No driving Golf Carts while under the influence of drugs or alcohol and no open alcohol containers permitted on the Carts. 10. Maximum of 4 people on the Golf Cart. Golf Cart drivers cannot have anyone sitting on their lap and no one is permitted to stand while driving. Pets are not permitted on Golf Carts. **Golf Cart Rules** a. Lessee must be a minimum of 18 years old. Operators of golf Carts must be 18 years of age and have in their possession a valid driver's license. (Moped license, learner's permit, etc. are not accepted). b. Golf Carts cannot be operated during quiet hours 11pm-8am. c. Golf Carts must be operated properly. Horseplay, racing, or other misuse of Cart will not be tolerated. Carts are to be operated on blacktop or gravel campground roadways designated for both cars and golf Carts (not on grass areas). Golf Carts are never to be used under the influence of drugs or alcohol. d. Golf Carts must remain on Normandy Farms property at all times and avoid areas where Golf Carts are not permitted. e. Golf Carts must be returned at the designated time. Late returned Carts will be charged \$20 for every hour late. f. Lost keys are \$25. g. Golf Carts can carry a maximum of 4 people. h. Please report any malfunctions to the Reception Center immediately. Golf Carts may not exceed 9 MPH. Anyone found abusing the rules and regulations of rental golf Cart will forfeit all rental privileges. There will be NO REFUNDS made if the Cart has to be returned because of Lessee misuse. k. You, as the renter, are responsible for the golf Cart and key at all times and therefore you are responsible for any and all damages that occur to the Cart during the time the campground is not in possession of the Cart. Be sure to place the parking brake on, the Cart in neutral and remove the key when parked. Initial that you've read and understand all the Golf Cart Rules. GOLF CARTS ARE ONLY TO BE OPERATED WITHIN THE CAMPGROUND BY A LICENSED DRIVER AND MAY NOT BE OPERATED BY ANYONE UNDER 18. PICK UP TIME AFTER 3PM; RETURN CART BY 12PM (or late fee of \$20/hr will incur) IF A GOLF CART IS FOUND BEING OPERATED BY AN UNLICENSED DRIVER OR ANYONE UNDER 18, OR IF IT IS BEING OPERATED IN A RECKLESS MANNER, THE GOLF CART WILL BE IMMEDIATELY REVOKED AND THE RESERVATION FOR THE GOLF CART WILL BE CANCELLED WITH NO REFUNDS ON ANY UNUSED TIME. - Golf Carts must be operated properly. Horseplay, racing, or other misuse of Cart will not be tolerated.
- Golf Carts are never to be used under the influence of drugs or alcohol.
- Golf Carts must remain on Normandy Farms property at all times and may not be ridden in designated areas. Carts are to be operated on blacktop or gravel campground roadways designated for both cars and Golf Carts (not on grass areas).
- Golf Carts must be returned at the designated time. Late returned Carts will be charged \$20 for every hour late.
- Lost keys are \$25.
- Golf Carts can carry a maximum of 4 people. No standing.
- Please report any malfunctions to the Reception Center immediately.
- Anyone found abusing the rules and regulations of a rental Golf Cart will forfeit all rental privileges. There will be NO REFUNDS made if the Cart has to be returned because of Lessee misuse.
- You, as the renter, are responsible for the Golf Cart and key at all times and therefore you are responsible for any and all damages that occur to the Cart during the time the campground is not in possession of the Cart. Be sure to place the parking brake on, the Cart in neutral and remove the key when parked.
